Creating Health & Hygiene Awareness in Adolescent Girls supported by Tata Motors Ltd.





Menstrual Hygiene Management was promoted through distribution of Menstrupaedia booklets. Sanitary napkins were given on a cost sharing basis. This has increased the attendance of Out-of-School girls at Health & Nutrition Education sessions.

Project Druv: Supported by the Tata Social Welfare Trust, the model aims to create accessibility to affordable and informative content by bringing digital connectivity to etelevision screens of Gram Panchayats commencing with 25 villages in Mokhada, Jawhar and Vikramgad.

Villages were surveyed by CHI staff to collect data on Socio-Economic profiles, village infrastructure and other information. Field tests of net speed connectivity were also conducted in the presence of Mr. Kalyan Jodhave - Project Manager, Malnutrition, in charge of the Druy project.

- Training of AWW on Incremental Learning Approach
- Behaviour Change Communication through the trained health staff.
